CRPA & NRA Update

Charter Member, Walt Mansel provided an update for the current batch of anti second amendment legislation working its way through the California State Legislature.

The State Legislature is currently adjourned, however there are bills to voted on the floor or at the appropriations committees.

AB809 (long Gun registration) suspended

AB819 (DROS Monies reallocation) suspended

SB124 (ammo law) at the appropriations committee (senate)

SB417 (open carry) on the senate floor for a vote

On the national scene, Illinois district appellate court affirmed the Supreme Court decision regarding handgun ownership in Chicago, They passed a law that citizens need safety certification to own the gun, however they closed all the ranges in the city limiting access to ranges to get the certification.
